- Candidate holds a current Green Belt Certification (CSSGB)
- Completion of at least 4 Six Sigma projects or 2 years of experience in the role of a SSGB participating/leading Green Belt level projects.
- Candidates must present for review a project portfolio for review and approval only then will the candidate be eligible for entrance into the BB Program

The project portfolio is required to assess the demonstrated skills and ability of the candidate in using the Lean Six Sigma methodologies. It will be evaluated by the TBI Master Black Belt.

\*The criteria contained in this application is in compliance with the published criteria of the International Association for Six Sigma Certification (IASSC).

# BASIC REQUIREMENTS FOR BLACK BELT APPLICATION

Candidates must meet the minimum scoring requirements for each of the noted performance indicators. Scoring is on a scale of 1-10 points

| Occupational Experience &           | 5 points  |

| Responsibilities                    |           |
| Technical Experience and Innovation | 10 points |
| Leadership                          | 10 points |

### NOTIFICATION OF RESULTS

Candidates should allow 3-5 weeks after their portfolio and application is submitted for a response for eligibility.

### SUBMISSION CONTENT

Candidates must submit...

- Current Resume
- Copy of (Lean) Six Sigma Green Belt Certification. The certification must be active.



- Six Sigma projects must relate to the Body of Knowledge (BoK) and exhibit a cost/revenue/performance transformation of at least \$50K-100K.
- Letter of Sponsorship from Supervisor (if applicable)

# **BURDEN OF PROOF – EVIDENCE**

In accordance to the **Body of Knowledge standards published by the Quality Industry**, the following statement is meant to describe what "evidence" is.

This criterion will be used by the LMBB when assessing whether eligibility is granted.

The BB Candidate bears the burden of proof for their submissions in support of this application and must present sufficient evidence with their application at the tie of submission. The burden of proof must be fulfilled by establishing positive evidence in support of the request for admission into the program. The LMBB will see to authenticate such evidence in terms of ownership, authorship or co-authorship where applicable. If the evidence submitted is inadequate or fails to satisfy the burden of proof by addressing the requirements, the candidate will have failed to establish adequately the burden of proof. This could result in the application being denied.



Evidence 1: All evidence submitted shall address or cover the BoK for a Certified Green Belt

Evidence 2: All evidence submitted shall authenticate the candidate's role clearly

Evidence 3: All evidence submitted shall be sufficient in completeness

Evidence 4: All evidence submitted shall be clearly labeled

Evidence 5: All evidence submitted shall be legible and clear in terms of presentation

Evidence 6: All evidence submitted shall be supported by employer verification or attestation
